**ORDER NO. 1**  
**GRANTING MOTION TO CONTINUE PRELIMINARY HEARING**

On July 3, 2013, Electro Purification, LLC (Applicant) filed its First Motion for Continuance (Motion), stating Applicant is without legal counsel for the scheduled July 11, 2013 preliminary hearing. Bluebonnet Underground Water Conservation District (the District), the only other party to the proceeding at this time, does not oppose the Motion. However, the District notes that it will be impossible to timely notify interested persons of the continuance and many people will make an unnecessary trip to Bellville, Texas, for the preliminary hearing. The District further requests that the State Office of Administrative Hearings (SOAH) provide a representative at the preliminary hearing site to explain the situation.

IT IS ORDERED that the Motion is granted and the preliminary hearing is continued to a date to be determined. IT IS FURTHER ORDERED that Applicant is to confer with the District and counsel for North Fort Bend Water Authority, the only entity requesting that SOAH conduct this hearing, to arrive at an agreed proposed hearing date. Applicant is to submit the agreed proposed hearing date to SOAH by **July 22, 2013**. IN ADDITION, IT IS ORDERED that the District, as proposed in its reply to the Motion, is to post a copy of this order on its website, send it to a list of interested persons the District maintains in this docket, and post it at the preliminary hearing site in lieu of SOAH providing a representative to explain the situation to any persons who appear.
