

NOTICE OF EMERGENCY MEETING

SIMONTON CITY COUNCIL AGENDA

Notice is hereby given of a special meeting of the City Council of Simonton, Texas, to be held on **Sunday, June 5, 2016, at 4:00pm** in the Simonton Community Church, 9703 FM 1489, Simonton, Texas, 77476 for the purpose of considering the following agenda items on an emergency basis.

An emergency or urgent public necessity exists because there is an immediate need to take action to address the unforeseen and imminent threat to public health and safety resulting from Brazos River Flood.

The City Council may recess into executive session for some of all of the discussion of these items as permitted under section 551.071(2) (consultation with the City's attorney) and section 551.076 (security personnel or devices) of Chapter 551 of the Texas Government Code.

1. Consideration and possible action on required City inspection audit to assess damage.
2. Consider and possible action to require remodel inspections to be conducted only for flood damaged structures.
3. Consider and possible action on requiring insurance standards for registered contractors at a 100,000 minimum with the City of Simonton as a certificate holder.
4. Consider and possible action on purchasing an emergency notification system.
5. Consider and possible action on hiring a emergency management coordinator to assist with the May flood event
6. Consider and possible action on expensing the City for the cost of electrical permits only for the May flood event which would be provided by CenterPoint Energy's field assessment.
7. Consider and possible action to reimburse personal expenses incurred by volunteers assisting with rescues.
8. Adjournment.
